Subject: - Debarring / Blacklisting of firm M/s Global Power Solution, Gurugram for submission of fake performance bank guarantees against NIT nos. TED-399 to TED-404, TED-407 and TED-410 to TED-415 for Loss Reduction Works (LRP) of Revamped Distribution Sector Scheme (RDSS) on turnkey basis under the jurisdiction of DHBVNL.

It is intimated that your firm (M/s Global Power Solution, Gurugram) had participated in the NIT nos. TED-399 to TED-404, TED-407 and TED-410 to TED-415 issued for the completion of Loss Reduction Works (LRP) of Revamped Distribution Sector Scheme (RDSS). The details of EMD (in form of Bank Guarantees) submitted by your firm against the NITs of which the technical bids were opened are tabled below:-

During the technical evaluation of bid submitted against TED-412 (Manesar Division), Nigam had forwarded the banker's certificate as a proof of Liquid Assets and bank guarantee submitted by your firm to the regional office of South Indian Bank, at Karol Bagh, New Delhi for verifying their genuineness & authenticity. However, the Bank vide their email dated 15.07.2023 had confirmed that the banker's certificate and bank guarantee are fake/forged and no such documents were issued by the Bank. It was further informed by Bank that it does not have any branch in Mahipalpur and the Manager/Asst. manager, addresses and mail ids; all are fake.

Further, the experience certificate and work orders submitted by the firm were forwarded to SE/TW, JDVNL, Jodhpur to verify their genuineness and correctness and they have confirmed that, their office had not issued the above-mentioned work experience certificates.

Subsequently, Nigam vide memo no. Ch-19 / DDD-234 / L-99 / RDSS / P&D dated 20.10.2023 had directed your firm to show cause within a period of 15 days to explain your position, as to why your firm may not be debarred / blacklisted from participating in future bidding processes of Dakshin Haryana Bijli Vitran Nigam Limited for a minimum period of five years.

Due to the non-responsiveness shown by your firm, a second 15 day Notice was served upon you vide Ch-20 / DDD-234 / L-99 / RDSS / P&D dated 10.11.2023. Even after the lapse of 20 days Nigam has not received any reply against the said notices, hence it is presumed that you have nothing to say, in the present matter and your firm had deliberate committed a forgery and tried to procure the work by adopting corrupt and fraudulent practices. The non-responsiveness further evinces your wrongful intentions and unethical business practices, which is not ignorable.

These actions demonstrate a breach of trust and integrity on your part. Thus, it is a misdemeanor on your part and unfair business practice which is totally unpardonable

Keeping in view the above facts, your firm is hereby blacklisted / debarred for 5 years from doing future business with Nigam.
