Subject:- Notification to amend the "Negative List" in Rules regarding Grant of Incentives, Concessions and Facilities to the Industrial Units in HP 2004 by HP Govt. – Amendment in Sales Manual thereof.

Sir,

Government of Himachal Pradesh, Department of Industries vide notification No. Ind.A(F)6-3/2017 VOL-II date 28.02.2019 has notified the amended "Negative List" in "Rules Regarding Grant of incentives, concessions and facilities to the Industrial Units in Himachal Pradesh, 2004". The negative list of industries is also appearing in Sales Manual Instruction No. 1.4.3 and in compliance to this amendment, the same also needs to be amended/updated accordingly.

In view of above, the list appearing under second paragraph of instruction No. 1.4.3 of Sales Manual from Sl. No. 1 to 22 is hereby amended/updated as under:-

1. Tobacco and tobacco products including Cigarettes and pan masala.
2. Thermal Power Plant (Coal/oil based).
3. Coal washeries/dry coal processing.
4. Tanning and dyeing extracts, tannins and their derivative, dyes, colors, paints and varnishes, putty, fillers and other mastics, inks.
5. Foundries using coal.
6. Minerals fuels, mineral oils and products of their distillation; Bituminous substances, mineral waxes.
7. Cement, Clinker and Asbestos raw including fiber.
8. Explosive (including industrial explosives, detonators & fuses, fireworks, matches, propellant powders etc.).
9. Mineral or Chemical fertilizers.
10. Insecticides, fungicides, herbicides & pesticides (basic manufacture and formulation).
11. Paper made of wood pulp.
12. Manufacture of pulp-wood pulp, mechanical or chemical (including dissolving pulp).
13. Plastics and articles which only include coloured polythene carry bags made of non-biodegradable material listed in the schedule to H.P. Non-Biodegradable Garbage (Control) Act, 1995, having thickness less than 70 microns and size less than 12"x18".
14. Production of firewood and charcoal.

The above instructions may be followed in letter and spirit.
