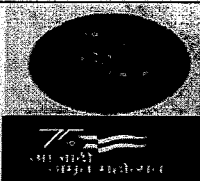

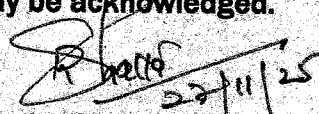
Sir,

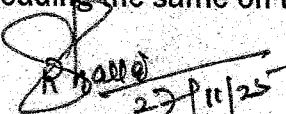
