Consequent upon above promotion, the transfers and postings of the following, Assistant Engineer (Electrical) are hereby ordered with immediate effect:

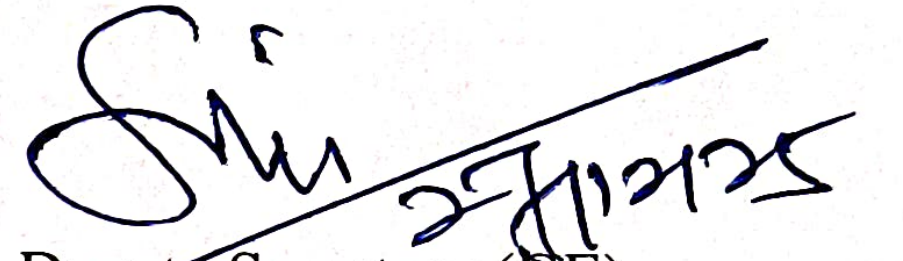

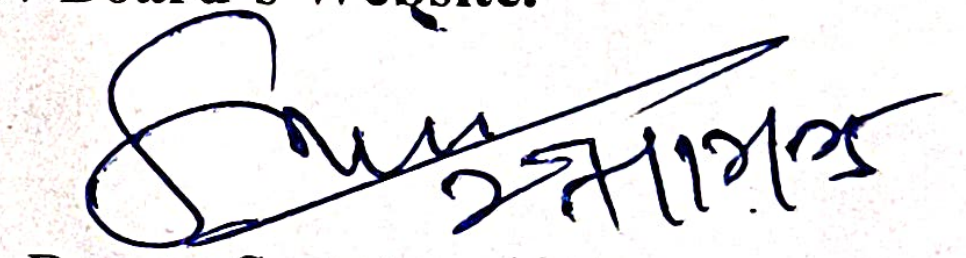
