1. On 24.09.2024. When the matter was last listed, Counsel for Complainant had prayed to file Application for Interim Reply in the Complaint which this Forum has permitted.
2. Today Application has been filed by Complainant M/s Satluj Jal Vidyut Nigam Limited (SJVN), for restraining the OP's from disconnecting the electricity connection bearing consumer ID-100014001801;
3. In the matter Complainant is of the opinion that there is threat of coercive action by the Respondent, pending the final disposal of the complaint and therefore seeks Interim Relief by way of this Application.
4. Complaint is admitted.
5. In accordance with regulation 25 of the HPERC(Consumer Grievances Redressal Forum and Ombudsman) Regulation ,2013, the Complainant is directed to deposit with the Respondent 1/3rd of the disputed amount of Rs.2,44,16,074/= equal to Rs. 81,38,691/= only. This shall be deposited by the Complaint with the

Respondent within a period of 10 days from this Order, i.e. on or before 08.10.2024.

6. On deposit of the ibid 1/3rd amounting to Rs. 81,38,691/=on or before 08.10.2024, the operation of Demand Notice No. 798-801dated.27.06.2024 raised by Respondent HPSEBL shall be stayed and no coercive action shall be taken by the Respondent against the Complainant.
7. The complaint is already fixed for 22.10.2024,when the Complainant shall place on record proof of deposit of the said amount of Rs. 81,38,691/=
8. In the event Complainant fails to deposit the said amounting Rs. 81,38,691/= on or before 08.10.2024 the Respondent shall be at liberty to take action as per extant Regulations.

On aforesaid terms the Application is disposed of.
