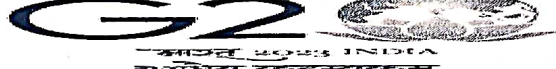

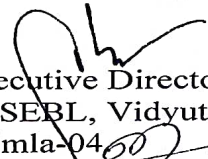

SC-cum-LA is having the brief of any category which has been assigned to some other Counsel, he/she may arrange to pass on the file to the concerned save and except the cases especially assigned to any of the Id. Counsel(s).

The instructions aforesaid are being issued in the interest of smooth representation in the cases before the Hon'ble Court and to avoid inconvenience to each other, failing which the matter shall be viewed seriously.
