In pursuance of the regularization policy of Himachal Pradesh Govt. vide No Per (AP)-C-B(2)-2/2015(AP-III) Department of Personnel dated 2.12.2023 and further adopted by the HPSEBL vide office notification, No.HPSEBL/Sect/PO Cell/369-1(Reg)/2023-24-32664-99 dated 4.9.2024.

I am to convey the approval of the authorities of HPSEBL to regularize the services of all the daily waged workers who have completed four (4) year services as on 31/03/2024 after verifying their documents before issuing them appointment orders.

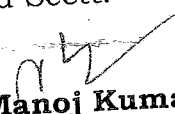
The regularization of daily waged workers will be from the prospective effect i.e. from the date of issue of appointment orders/joining. The regularization should be of only those daily waged workers whose cases are not pending before different ad-judicatories.

You are therefore, requested to issue appointment orders after completing of all codal formalities in respect of the daily waged workers who are eligible for regularization. The pay of the incumbent will be regulated as per the instructions/notifications issued by HPSEBL from time to time.
