**Subject:- Regularization of daily waged workers on regular basis who
have completed 5 years or more as on 30/9/2021 and
continuously working-approval thereof.**

Sir,

In pursuance of the regularization policy of the HP Govt. and further adopted by the HPSEBL Ltd vide office notification No. 6894-6928 dated 28.4.2021. I am to convey the approval of the authorities of HPSEBL to regularize the services of daily waged workers who have completed 5 years or more as on **30/09/2021** after verifying their documents before issuing them the orders and taking their appointments.

The regularization of daily waged workers will be from prospective effect i.e. from the date of issue of appointment order/joining. However, the upper age limit and educational qualification for Class-IV Tech/Non Tech. is relaxed as per the instruction issued vide letter No.HPSEBL(Sect)/R&E/106/11/2010-30948-31148 dated 5.6.2010. The regularization should be only for those workers whose cases are not pending before different ad-judicatories.
