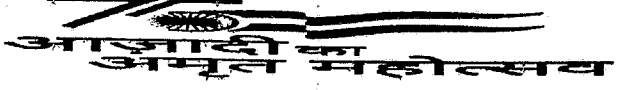

In pursuance to the Under Secretary (Personnel) to the Government of Himachal Pradesh office letter No. PER (AP) C-B (2)-1/2019 dated 28th December, 2021 and further adopted by the HPSEB Limited vide his office order No. HPSEBL (SECTT)/R&E/Govt. Instt. Contract/2021-64561-781 dated 30.12.2021, the services of the Ms Swati Pathania (DOB 18.03.1991) **Junior Office Assistant (Accounts)** appointed in the Board on contract basis vide Memorandum No. HPSEBL(Sectt)/NGE/6-78/2019-48334-42 dated 31.10.2019 and as such has joined on 11.11.2019 in **Electrical Division, HPSEBL, Dharamshala** and has completed (2) two years continuous services as on 10.11.2021 and her services as JOA(Accounts) is hereby regularized w.e.f.01.04.2022 in her present office/post in the initial pay scale Rs. 5900-20200+1950 Grade Pay+ allowances as applicable from time to time.

The regularization is subject to observing following codel formalities.

1. All the original certificates of the official viz Himachali/Academic & Technical qualification, SC/ ST/ OBC/ ESM/ Sports/ Disability will be got verified by the concerned Head of office at the time of her joining on regular basis.
2. The Character & Antecedent Report of above named official is to be got verified from the concerned competent authority within the period as required under rules.
3. The seniority of the above mentioned official will be fixed in the respective cadre later on. However, the entitlement of leave(s) etc. under CCS (Leave) Rules shall accrue to the officials from the date of issue of these orders.
4. The contractual appointee who is regularized shall be liable to be posted anywhere in the State.
5. Necessary entry to this effect is required to be recorded in the service book of concerned official.
6. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
7. His /Her appointment will be subject to the production of Medical Certificate of fitness from the Medical Officer of the Government Hospital.
8. She/He should give a declaration that he has got only one living wife/husband or is a bachelor.
9. She/He will have to take oath and undertaking in writing that he/she will not leak-out any official information.
