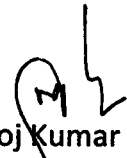
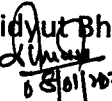
I am directed to inform you, that it has been noticed by the authorities of HPSEBL, that numbers of Jr. T-Mate(s) and Jr. Helper(s) have been deputed temporarily in another Divisions/ Circles of HPSEBL, since 2019 and 2020. Thus, their place of posting is different than their actual posts exists. However, according to the notification of the HPSEBL vide office memorandum dated 14.01.1976 it was decided that the transfer of field technical staff born on Divisional/ Circle level may be ordered by the competent authority subject to their losing seniority in the Division/ Circle from which they are transferred. Their seniority is to be dovetailed at the end of the seniority list of their corresponding cadre of Divisions/ Circle to which they are transferred.

Besides this, HPSEBL is pleased to decide that all the Junior T-Mates and Jr. Helper (s) working in HPSEBL be extended an opportunity for those officials who are willing for transfer to their choice of station against availability of vacancy according to the roster applicable for such categories. This will be purely as one time settlement and no further temporary/ permanent transfer will be made on this ground in future.

In view of above, you are therefore, requested to obtain the willingness of all the interested Jr. T-Mate (s) and Jr. Helper (s) alongwith undertaking with regard to their forfeiture of seniority and the category against which they were recruited/regularized on the prescribed Performa enclosed, so that the transfer cases could be examined in the right perspective in accordance to the roster applicable to these categories. The requisite information be supplied to this office alongwith undertaking through special messenger within 10 days from the date of receipt of this communication positively on the Performa enclosed herewith duly signed by the Cadre Controlling Officer.

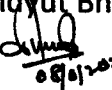
