This office has constituted screening committee vide this office order No. HPSEBL/(SECT)PO/369-1/(Reg.)/2014-31624-68 dated 22.08.2014 & even No. 101671-721 dated 24.03.2017 will remain the same and you are therefore requested to call all the daily waged workers who have completed 5 (Five) years or more as on 31.03.2020 to appear before the concerned screening committee to verify their service particulars from the original records/certificates as per the prescribed proforma already supplied. After verifying the service particulars of all the daily waged workers the committee will record a certificate at the bottom of each list to the effect that the particulars so inserted in the list have been verified and found correct as per records and name of workers are recommended for granting regular status. The screening committee report/ list must reach this office on or before 30.05.2020 positively, without fail, through special messenger please.
