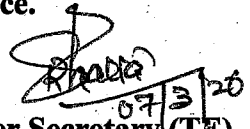

Both the officials will be entitled to TTA and joining time as admissible under rules.

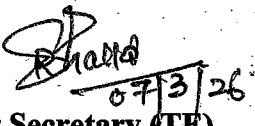
