1. Complaint has been filed by consumer bearing ID 200009000696;
2. Complaint is accompanied with Application under regulation 25 of the HPERC (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 praying therein for staying demand of Rs 5,89,027.67 and further directions to Respondent not to disconnect electricity meter of Complainant / Applicant;
3. Counsel for Complainant present today consents to deposit $\frac{1}{3}^{\text{rd}}$ of the disputed Rs 5,89,027.67 amounting to Rs 1,96,343/- in accordance with the said HPERC Regulations;
4. Complaint is admitted;
5. Forum from examination of complaint finds that the said demand of Rs 5,89,027.67 has been raised as sundry by the Respondent in electricity bill dated 05.07.2025 enclosed and labeled as **Annexure C5**;

6. Forum observes that copy of complaint has been forwarded to the Respondent by post;
7. In accordance with regulation 25 of the HPERC (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, Complainant / Applicant is directed to deposit with the Respondent the said $\frac{1}{3}^{\text{rd}}$ of the disputed Rs 5,89,027.67 amounting to Rs 1,96,343/- on or before 03.09.2025;
8. On deposit of the said $\frac{1}{3}^{\text{rd}}$ amounting to Rs 1,96,343/-, the impugned demand raised of Rs 5,89,027.67 shall remain stayed till further Orders;
9. On the next date, Complainant is directed to place on record proof of deposit of said $\frac{1}{3}^{\text{rd}}$ amounting to Rs 1,96,343/-;
10. On non-payment of the aforementioned monies amounting to Rs 1,96,343/- by 03.09.2025, the Respondent shall be at liberty to take action as per extant law / regulations governing the power sector;
11. It is made clear that this stay is only against the disputed amount of Rs 5,89,027.67 raised a sundry in said electricity bill dated 05.07.2025;
12. On aforesaid terms the Application is disposed;
13. Registry of Forum is directed to issue Notices to Respondent(s);
14. Main complaint to come up for Reply on 03.09.2025;
