Etc. Versus State of Himachal Pradesh & Ors. Etc. with Civil Appeal Nos.6652 of 2021 titled HPSEB Ltd. Vs. Arjun Singh & Ors. and Civil Appeal Nos.6651 of 2021 titled HPSEB Ltd. Vs. Vipin Kumar & Ors. read with CWP Nos. 11/2019 & 12/2019 orders dated 04.03.2020 passed by the Hon'ble High Court of HP at Shimla from the Accounts Personnel's who have been re-positioned/downgraded to the lower grade on account of services rendered by them on their promotional posts.
