The seniority of the above named officer in the grade of Section Officer will be fixed later-on.

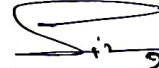

The above named officer will be entitled to usual TTA / JT as admissible under the rules.

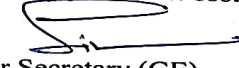

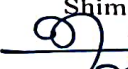
