ORDER

Whereas, the petitioner namely Sh. Anil Kumar S/O Sh. Krishan Chand R/O Village Kadriana, PO Didwin, Tehsil and District Hamirpur HP had filed a CWP No. 2272 of 2025 before the Hon'ble Court of HP at Shimla HP praying therein the following reliefs namely:-

- I. That any appropriate writ/order or direction in the nature of certiorari may kindly be issued and the impugned transfer Order dated 06.02.2025 at Annexure P-2 may kindly be quashed qua the present petitioner.**
- II. That any appropriate writ/order or direction in the nature of mandamus may kindly be issued and the respondents may be directed to permit the petitioner to continue as Sr. Executive Engineer (Elect) in the O/o of SE (Design) ES Hamirpur, District Hamirpur, Himachal Pradesh.**

Whereas, the aforesaid writ petition came up for hearing before the Hon'ble High Court of HP on 10-02-2025 and the transfer order dated 10-02-2025 was stayed. The writ petition aforesaid was again come up for hearing before the Hon'ble High Court of HP on 11-03-2025 and on that date, the Hon'ble Court was pleased to pass the following directions:-

Learned counsel for the respondents submits that in view of instructions dated 06.03.2025, which were placed on record of the case during previous hearing, the respondents-HPSEBL is willing to consider the cases of the petitioners for their adjustment as per these instructions.

Let the petitioners submit representations to respondent No.1 within two days, whereafter, the same be examined by respondent No.2/Competent Authority within a week.

List these matters on 22.03.2025 when fresh status report shall be filed by the respondents. Interim orders to continue till next date of hearing.

Whereas in compliance to the directions passed by the Hon'ble High Court of HP dated 11-03-2025 the petitioner has filed a representation dated 12-03-

2025 through his advocate requesting therein to adjust him against a longer stayee in the O/o SE (D), ES, Hamirpur HP

As such keeping in view the averments made by the petitioner in his representation as well as the directions passed by the Hon'ble High Court of HP dated 11-03-2025, the request of the petitioner is considered and he is hereby ordered to be transferred/adjusted in the O/o Superintending Engineer, (Design), Electrical System, Hamirpur vice Er. Puneet Kumar Chaudhary. Further Er. Puneet Chaudhary is hereby ordered to be transferred from O/O Superintending Engineer, (Design), Electrical System, Hamirpur to the O/o SE (DSP) under CE (SP) HPSEB Ltd. Shimla.

Er. Puneet Chaudhary shall be entitled to TTA and joining time as admissible.
