The Complainant has filed an application on dated 24.07.2024 for granting stay on under billed/ less billed amounting to Rs. 29,41,028/- only before this Forum.

The Complainant also provided order of Hon'ble High Court in CWP No. 7004/2024 in the matter M/s Classic Engineering Works V/s HPSEBL & Ors. Further had also filed a review application in High Court vide CMP No. 12427/2024. Vide CMP No. 12427/2024, wherein Complainant has been granted four weeks stay for implementation and execution of order dated 25.05.2024

The Complainant personally approached this Forum today on 27.08.2024 for grating stay against the order issued by Assistant Engineer E.S.D Sansarpur vide demand notice dated 25.05.2024 vide annexure P-1.

The application for the interim stay is disposed of today with the direction to the Complainant to deposit 1/3rd of disputed demanded amount of short recovery on account of under billed/ less billed amount to the tune of Rs. 29,41,0288/- raised vide demand notice dated 25.05.2024 .

1/3rd of the ibid monetary demand of Rs. 29,41,0288/- amounting to Rs. 9,80,342/- shall be deposited by the Complainant within a period of 10 days from this order with Assistant Engineer E.S.D Sansarpur from the issue date of this order and the Respondent Board shall not take any coercive action for disconnection of supply till further orders.

In case the Complainant fails to deposit 1/3rd amount within a stipulated period in that eventuality Respondent Board shall be at liberty to take action as per extant Rules/ Regulations on the matters.

Further Complainant is required to produce the receipt of the same before the Forum on the next date of admission hearing i.e. on 06.09.2024.
