ORDER

The case was listed for final order today. The Ld. Counsel for the complainant submitted today that the Respondent Board has allowed a total rebate of Rs 41,656.16/- on LPS over and above the rebate already provided to complainant to the tune of Rs. 2,51,778.69/-. The rebate so provided by Respondent Board to the complainant is agreed to and accepted by the complainant. The Ld. Counsel for complainant further submits that some time may be allowed to pay remaining balance outstanding demand charges which shall be paid by the complainant with in a period of two months from today. The Respondent Board today submitted the statement reflecting total outstanding balance amount after rebate which now calculated to the tune of Rs.6,20,064.75/- and the same is to be paid by the complainant with in a period of two months as promised.

In view of the submission made herein above, the present complaint is disposed off with a direction to complainant to ensure the repayment of the balance outstanding amount stated in the para above, with in a period of two months i.e. on or before 28.02.2022 without fail as promised. The complainant shall also ensure the repayment of current energy bills regularly in future. In case the balance outstanding amount Rs.6,20,064.75/- is paid by the complainant with in a period of two months as directed, in that eventuality no late surcharge shall be levied by the Respondent Board on the said amount. The Respondent Board shall be competent to claim late surcharge on the said amount as per extant Regulation in case the complainant fails to deposit it within stipulated period. In the aforesaid terms the present complaint stands disposed of today on 14.12.2021 in the presence of the parties.
