Clarification on Himachal Pradesh Govt. Instruction contained in OM
No. Fin (Pen)A(3)-1/96 dated 18.09.2017.

Sir/Madam,

I am directed to refer to this department Office Memorandum No. Fin(Pen)A(3)-1/96 dated 18.09.2017, whereby, the benefit of retirement gratuity and death gratuity was allowed to the Govt. employees covered under defined Contributory Pension Scheme (New Pension System) on the terms & conditions as applicable to the employees governed by the CCS (Pension) Rules, 1972.

References are being received from various quarter seeking clarification on applicability of Govt. instructions contained in O.M. No. Fin(Pen)A(3)-1/96 dated 18.09.2017 to the NPS employees.

In this regard, it is clarified that Govt. instructions contained in Office Memorandum No. Fin(Pen)A(3)-1/96 dated 18.09.2017 have been made applicable from the date of publication of these instructions in the Rajpatra. The instructions dated 18.09.2017 have been published in the Rajpatra on 22.09.2017. Therefore, benefit of retirement gratuity and death gratuity shall be admissible to the Govt. employees covered under Contributory Pension Scheme (also called New Pension System) who are retired/died in harness on or after 22.09.2017 only. Hence, instruction contained in O.M. No. Fin(Pen)A(3)-1/96 dated 18.09.2017 may be implemented strictly as has been clarified above, while processing & finalizing retirement gratuity & death gratuity cases of NPS employees.
