Subject: - Regarding amendment in standard format of R&P Rules.

Sir/Madam,

I am directed to refer to letter No.Per(AP)C-A(3)-5/2003-I dated 25-7-2016, vide which the revised standard format of R&P Rules was circulated by this department. Now, it has been decided by the Government that the existing provisions against Col. No.15-A(VII)(b), (f) and Sr. No.3 and 7 of Annexure-B of the standard format of R&P Rules may be substituted as under:-

Col. No.15-A(VII)(b) and Sr. No.3 of Annexure-B

"The service of contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. In case the contract appointee is not satisfied with the termination orders issued by the Appointing Authority, he/she may prefer an appeal before the Appellate Authority who shall be higher in rank to the Appointing Authority, with in a period of 45 days, from the date on which a copy of termination orders is delivered to him/her."

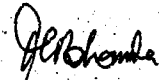
"Selected candidate will have to submit a certificate of his/her fitness issued by a Medical Board in the case of a Gazetted Government servant and by Government Medical Officer in the case of a Non-Gazetted Government servant. In case of women candidates who are to be appointed against posts carrying hazardous nature of duties, and in case they have to complete a period of training as a condition of service, such woman candidate, who as a result of tests is found to be pregnant of

twelve weeks' standing or more shall be declared temporarily unfit and her appointment shall be held in abeyance until the confinement is over. Such woman candidate be re-examined for medical fitness six weeks after the date of confinement, and if she is found fit on production of medical fitness certificate from the authority as specified above, she may be appointed to the post kept reserved for her."

Since the concurrence/approval of Finance, Law Department and H.P. Public Service Commission as well as the Council of Ministers has already been obtained in the matter, therefore, it is requested that necessary amendments in provisions against aforesaid columns of Recruitment & Promotion Rules in your department may be carried out accordingly.

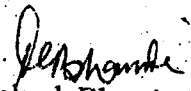
