The instant complainant is accompanied with additional Application dated 27/8/2024 for interim relief. The Complainant has prayed for restraining respondent from claiming of Rs.6,15,695.94, raised vide bill No 160000894345 dated 8/8/2024 and further disconnecting the electricity, till the pendency of the complaint.

Perusal of the complaint shows that demand of amount of Rs.615695.94 has been raised on account of short assessment of demand charges. The applicant has also annexed Bill NO 160000894345 Dated 08/08/2024.

In Accordance with regulation 25 of HPERC (Consumer Grievances Redressal forum and Ombudsman) regulation 2013, Stay is granted as requested ibid above.

The Complainant is directed to deposit 1/3rd of the disputed amount of Rs.6, 15, 697.94/- amounting to Rs 2, 05,231.98 within 10 days from the issue of this order. On deposit of this 1/3rd amount within the stipulated time given, Respondent is directed not to take any coercive action against the Complainant.

The applicant after deposit of 1/3rd amount shall place on record the Receipt of deposit of this amount with a copy to Respondent, on failure of Complainant to deposit 1/3rd amounting of Rs.2,05,231.98, the Respondent HPSEBL may take action as per extent Rules/Regulation on the matter and stay granted vide this Interim Order shall automatically stand vacated.

On the aforesaid terms the application filed by applicant is disposed of.
