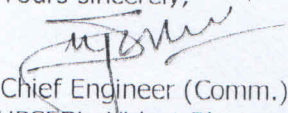
This is with reference to letter No. 01-350 dated 07.04.2020 on the subject cited above vide which it has been decided to issue the bills for Consumers covered under on average basis.

It has been decided by the competent authority that no late payment surcharge shall be levied for the bills generated on the basis of average consumption for the consumers covered under Single Part Tariff Category till they receive the normal bill.

In addition to above, it has also been approved to extend the rebate of Rs.10 for domestic consumers to pay the bill online through digital payment as allowed earlier vide office order No. 774-1123 dated 22.04.2020 for a period of six months.

This is for your information and further necessary action please.

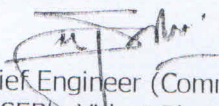
