A copy of syllabus of examination and following instructions may be brought to the notice of all the candidates:

- (a) No traveling allowance will be paid by the Commission.
- (b) The candidate shall not bring any Pager, Mobile Phone, Bluetooth, Earphone, Microphone, Laptop, Camera, Pen Drive, Electronic Pen / Scanner or any other type of gadget / electronic device in the examination hall / rooms, as arrangement for its safe custody cannot be assured.
- (c) The candidates are advised to bring their own water & sanitizer (in transparent bottles) and wear masks during the entire period of exam etc. to contain the spread of COVID-19.
- (d) No candidate will be allowed to enter the examination hall / rooms without mask and thermal screening.
- (e) Candidates are advised to download the " Arogya Setu App". They are further advised to maintain social distancing and avoid crowding at entry and exit points.
- (f) Candidates should note that the Commission doesn't supply any article of stationery except answer books. In case any candidates brings any unauthorized material/ books in the examination hall, he/ she shall not only be liable to be disqualified from appearing in the paper or whole of the examination but even such unauthorized books shall be seized by the supervisor appointed by the Commission for the conduct of examination.
- (g) The candidates should bring with them identity card on the enclosed prescribed performa.
- (h) The candidates should reach the examination centre, one hour before the Commencement of the examination.
- (i) The candidates are not permitted to carry mobile phone, pager or any type of gadget for communication in the Examination Hall.
- (j) The candidates should sit only against their own Roll Numbers allotted by the Commission failing which responsibility shall lie on the candidates.
