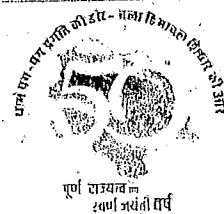
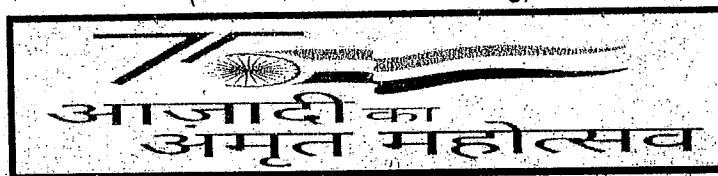

The contractual appointee who are regularized shall be liable to be posted anywhere in the State.

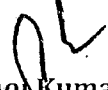
