Subject: - Regarding deduction of GPF Subscription from the salaries even after 28.02.2007 of those Govt. employees who have been appointed/regularized after 14.05.2003.

The Executive Director (Pers,) HPSEBL Vidyut Bhawan Shimla-4 vide his office order endst.No.HPSEBL (SECTT)/R&E/GPF/6-155 2017-61329-609 dated 25.10.2017, circulated the instructions issued by the Special Secretaries (Fin,) to the Govt. of H.P vide his letter No. Fin(C) A (3)-13/2016 dated Shimla-2 dated 18.03.2017 to all the field offices of HPSEBL including deputation offices regarding non adhering the instructions issued by the Finance Deptt. to the various DDOs **(Copy enclosed).**

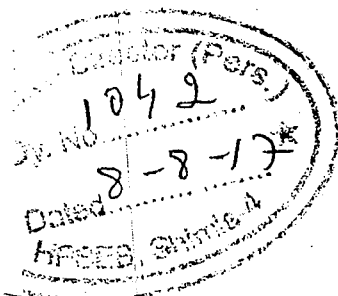

I am directed to say that it has been brought to the
notice of this Department by the Accountant General (A &E) H.P. Shimla
that various DDOs of the State Government are still deducting the GPF
subscription from the salaries even after 28.2.2007 of those Govt.
employees who have been appointed/ regularized after 14.5.2003, as these
employees are covered under the Contributory Pension Scheme (Copies of
appendix-2 and 3 received from the AG Office are attached herewith for
ready reference).

2. The Finance Department vide notification No. Fin © A(3)-6/96-
II dated 15th September, 2006 has made inapplicable the GPF(CS) Rules,
1960 in respect of those Govt. employees who have been appointed on or
after 15.5.2003 and are covered under the provisions of the Contributory
Pension Scheme notified by the State Government. Thereafter, a
corrigendum has been issued by the Finance Department vide No. Fin (C)
A(3)-6/96-II dated 17th February, 2007 which provides that the amount
deposited in the GPF Account of an employee appointed after n or after
15.5.2003 shall be transferred to the respective Contributory Pension Fund
Account alongwith interest. In case the balance in GPF Account alongwith
interest is found excess to the amount required to be adjusted towards
arrears of the employees contribution towards Contributory Pension
Scheme, the same shall be refunded to the individual and in case the
balance in GPF account falls short of the prescribed limit the same shall be
