Subject: Regularization of contract appointees in the Government Departments-
Instructions thereof.

Sir,

I am directed to say that the HPSEBL has adopted the instructions issued by the Additional Chief Secretary (Personnel) to the Govt. of H.P. vide No. Per (AP)C-B(2)-1/2019- dated 22.4.2020 and has circulated in HPSEBL vide this office endorsement No (Sectt) /R&E/ Govt. Instn-Misc/2020- 89642-862 dated 24.4.2020 for implementation in toto. As per condition No. 9 (ix) of the instructions, the regularization of the contract appointee who have completed three (3) years of continuous services as on 31.3.2020 shall be regularized. Further the services of contractual appointee who are completing three (3) years of continuous service as on 30.9.2020 shall also be regularized after 30.9.2020. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.

The instructions in this regard were issued from time to time. However, the matter has been re-examined and it has been decided that the regularization of the contract appointees who have completed three (3) continuous services as on

Ans

1.4.2020 shall be regularized prospectively i.e. w.e.f. 22.4.2020. It has also been decided that the regularization orders of contract appointees in all categories issued w.e.f. 1.4.2020 be withdrawn and revised orders be issued w.e.f. 22.4.2020 accordingly. Hence all the instructions issued in this regard by this office earlier are modified to this extent as decided above.

In view of above, all concerned are directed to withdraw the regularization of contract appointees issued by them w.e.f. 1.4.2020 immediately and simultaneously issue revised regularization orders w.e.f. 22.4.2020. Compliance be reported to this office.
