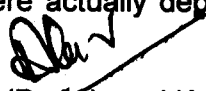

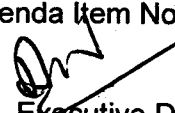

- i) Risk Allowance will be admissible only to those who actually perform duties involving risk to life:
- ii) Risk Allowance will not be admissible during the period of Training, Suspension and leave of any kind other than casual leave:
- iii) This allowance will not be admissible to those entitled for Hotline Allowance.
- iv) This allowance will further be subject to the condition that the controlling Officers concerned will have to issue/record a certificate to the effect that the official concerned i.e. Junior T/Mates to whom the Risk Allowance is being granted were actually deployed on the jobs involving risk to life.
