OFFICE ORDER

No. 91 HPSEBL(SECTT)/2024-

WHEREAS Er. Santosh Kumar, Sr. Executive Engineer (Elect.) has been transferred from Pangi Valley Elect., Divn., HPSEBL, Killar to Elect., Divn., Dharampur vice Er. Sunil Kumar, Sr. Executive Engineer (Elect.) vide office order No. 211 dated 31.8.2023, whereby being aggrieved with above orders, he filed CWP No. 6263/2023 titled as Santosh Kumar V/s HPSEB Ltd. in the Hon'ble High Court at Shimla with the plea that his transfer order may be quashed or adjusted at some other station.

AND WHEREAS the aforesaid CWP came up for hearing before the Hon'ble High Court on 13.5.2024 and the Hon'ble High Court passed the direction/order as :

“After making his submission for some time, learned Counsel for the petitioner submits that the petitioner be permitted to withdraw the petition, but with liberty that he be adjustment at some other station as, as per his instructions there is-likelihood for some re-shuffling in the respondent-Board and in the course of the re-shuffling the petition can also be adjusted.

AND WHEREAS in compliance to above directions of Hon'ble High Court the said petitioner Er. Santosh Kumar submitted a representation dated 14.5.2024 claiming thereby that he may be adjusted in one of the five stations mentioned in his letter.

AND WHEREAS the competent authority has considered representation dated 14.5.2024 of the applicant and due to non availability of vacancy at his choice of stations, he could not be adjusted at his choice of station.

Now therefore, keeping in view of Hon'ble High Court order dated 13.5.2024 and taking into consideration the representation of the petitioner, the office order No.211 /HPSEBL(SECTT)/2024 dated 31.8.2023 endorsed vide No.HPSEBL(SECTT)/101-11/2024-40815-960 dated 31.8.2023 is made operative with immediate effect.
