Interim Order

(The previous date of hearing in the complaint was 17.10.2022).

None for the Complainant. The Complainant has through post submitted an Application dated 04.11.2022 for restoration of proceedings in the complaint consequent to the Order of the Ld. Ombudsman passed in case No.9 of 2022 and for Interim Orders to restrain the respondent from taking coercive action during such time the dispute is pending. Copy of the Order passed by Ld. Ombudsman has been placed on record, whereby the Ld. Ombudsman is pleased order as follows:-

Quote:

1. The interim orders passed by the Consumer Grievance Redressal Forum on dated 22.04.2022 in Complaint No. 1451/02/22/13 are hereby quashed and set-a-side.
2. The Orders passed by the Consumer Grievance Redressal Forum on dated 04.06.2022 in Complaint No. 1451/02/22/13 dismissing the same are erroneous, not sustainable and without jurisdiction and are hereby quashed and set-a-side.
3. The matter is remitted back to the Consumer Grievance Redressal Forum to entertain the Complaint of the Complainant with directions to consider the entire amount of

Rs.1,67,85,000/- disputed by the Complainant towards IDC as disputed amount and also to consider Rs.1,24,38,800/- as the amount already deposited with the Respondent Board which works out to approximately 74% of the disputed amount.

4. The Consumer Grievance Redressal Forum is further directed to decide the case in Complaint No.1451/2/22/13 on merit after affording the opportunity of being heard to respective parties in order to adhere to the principle of natural justice.

In view of the ibid Order of the Ld. Ombudsman, the Forum has already issued the Notice dated 29.10.2022 to the parties concerned for filing Reply on or before 14.11.2022. The Respondent Board today prayed to allow time to file Reply on Application submitted by Complainant for restoration, as well, as Interim directions as the same could not be filed today. The prayer of Respondent Board is allowed. The complaint to come-up for Reply by the Respondent Board on Application as well as on the main complaint which is restored in compliance of the Order of the Ld. Ombudsman dated 26.10.2022, to dispose of the complaint on merits after affording opportunity of by being heard to respective parties. To come-up for Reply on 30.11.2022.
