ORDER

1. The briefly stated facts of the case are that complainant company is an EHT consumer getting supply at a voltage of 66KV having then connected load of 7400KW of load with 7502 KVA of contract demand. The HPERC, notified tariff order applicable for financial year 2019-20, which is applicable to category of complainant i.e. EHT category of Large Industrial Power Supply (LIPS) category of consumers. The said regulations provide for a rebate of 15% an energy charges applicable for additional power consumption during FY 2019-20 beyond the level of FY 2018-19 as per Para Note (a) to Para 3 (b) of the LIPS tariff notified by the commission. The complainant submits that rebate tell due. Immediately at the end of FY 2019-20, i.e., on 31.03.2020. The respondents raised a bill for the period 29.02.2020 to 01.04.2020, in which new reading was taken on 01.04.2020. Without adjusting the rebate, respondents raised the bill and issued it on 12.04.2020. The complainant claims the refund of rebate of Rs.65,08,371.75 as per Annexure-2. Which has become overdue in view of present CIVID-19 Pandemic facing lots of hardships. The complainant also prays for simple interest @ 15% as per period of delay in adjustment w.e.f. 01.04.2020.
2. The Respondent Board through its authorised representative Sh. Robin Kumar, Sr. XEN, Baddi, present on 18.08.2020, submitted that the admissible rebate as per the extant regulations and relevant MYT order for fourth control period (FY 20-FY 24) notified by Hon'ble HPERC under LIPS Tariff, has been calculated and provided to the tune of Rs.55,48,2600/- to the complainant for relevant period in energy bills raised for August, 2020. The complainant did not dispute the submissions of the Respondent Board and consented for disposal of the complaint accordingly.
3. We have heard the parties. In view of the submissions made here-in-above, in respect of the refund of rebate to the complainant as per extant tariff notified by the Hon'ble HPERC for the category of LIP's in its MYT order for Fourth control period (FY 20-FY 24), as placed on record by the complainant as **Annexure C-1**; the instant complaint is disposed of, as the admissible refund of Rs.55,48,2600/- has been provided to complainant in the energy bill of August, 2020, which is not disputed before us. Thus, nothing survives in the complaint as per above submissions. The parties, are left to bear their own costs.
