Application has been filed before the Forum by Respondent HPSEBL, on 21<sup>st</sup> July 2023 and prayed for the matter to be listed. This Application has been filed pursuant to the Orders passed by Hon'ble HP High Court on 11<sup>th</sup> November, 2019 in civil writ Petitions No. CWP 4912 of 2012 and connected CWP 9261 of 2012, filed before Hon'ble Court by Respondent HPSEBL.

From examination of record, Forum observes that no previous Application has been filed by the Respondent HPSEBL for the restoration of the complaint, before any previous Forum, nor is there any Notice available on record that may have been issued by Hon'ble Court to the previous Forums in the ibid CWPs, nor are the ibid CWPs available on record.

Assistant Engineer Electrical Sub Division Kasauli who is present today, informs that due to the fact that no permanent incumbent was posted in the concerned office of the Respondent for the past few years, as a result no Application for restoration of Complaint could be filed during the previous years. However, the forum observes that this fact has not been pointed out in the instant Application.

In the matter, the Forum further observes that in order to effectively adjudicate upon Complaint, it is necessary for the Respondent HPSEBL to place on record the aforementioned CWPs and for the Secretary (CGRF) to place on record any Notice that may have been received in the past from the Hon'ble HP High Court in the said CWPs.

Accordingly Form directs the Respondent HPSEBL to place on record copy of ibid CWPs on or before next date of hearing which is 24/08/2023.

Further, the Secretary of this Forum is directed to place on record, on or before the said next date of hearing, any Notice that may have been received from the Hon'ble HP High Court in the said CWPs.

Matter be listed for further hearing on 24.08.2023.
