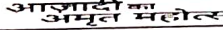

This is in supersession of all previous orders issued in this behalf.

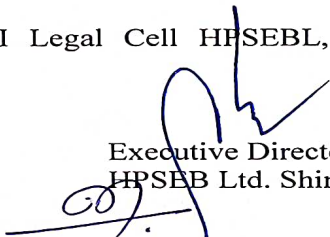

(1) All cases e.g Civil suits/Complaints/ etc. before the District Courts/ Labour Court/ State Commission/ Commission WCC/Chief Electrical Inspector etc	₹3000/-(consolidated) per case
(2) Misc. Expenses on account of Court fee, process fee, diet money, copy of judgement etc.	As per actual

50% amount on account of fee shall be paid as soon as the case is taken up by the Standing Counsel(s)/Lawyer(s). The balance amount shall be paid on culmination/conclusion of the case. For tendering legal opinion by the Standing Counsel(s), no fee and or remuneration will be admissible.

The cases in which 50% fee has been claimed by the earlier Counsel(s) only balance part/remaining 50% fee will be admissible in respect of pending cases. The vice appearance by an advocate should only be in formal hearing and not in effective hearing in a case.
