A certificate to the effect that none of the officials of the above categories of any objection and have been left to be included in the seniority list may also be furnished to this office at the earliest.

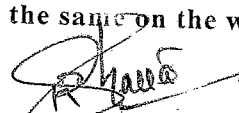

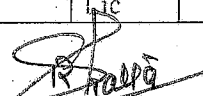

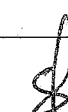
