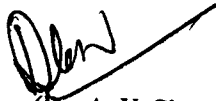
WHEREAS, Sh. AND WHEREAS, Sh. Jagdish Chand, Personal Assistant vide his application dated 18.06.2020 apprised to forego his promotion as Additional Private Secretary forever (i.e. till his retirement), due to his unavoidable domestic circumstances.
