ORDER

The Complaint was filed by the Indian Institute of Advanced Study, Rashtrapati Niwas, Shimla-5, when dispute arose owing to Demand Notice dated 09.03.2022 for Rs. 4,77,111/- raised by Respondent Board. The matter was listed today for hearing and to intimate the outcome of settlement between the parties as was directed by this Forum on the last date of hearing. The Ld. Counsel for the Complainant today placed on record the document Annexure A-I dated 05.09.2022 whereby the Respondent Board has intimated about the amicable settlement and the consent of the Complainant to pay the principal amount of Rs.4,77,111/-. Another Annexure A-II has also been placed on record today by the Complainant dated 26.09.2022 which is in terms of the Acceptance of the offer by Complainant made for settlement of dispute involved in present complaint and whereby the parties have agreed to settle the complaint amicably on the basis of compromise. The Respondent Board submitted that the present complaint may be disposed of in view of the documents placed on record by the Complainant. In view of the observation made herein above, the present complaint is disposed of with direction to the Complainant to deposit the balance amount of Rs.4,77,111/- as settled between parties, within period of one month. In the aforesaid terms the present complaint is disposed of as not pressed for, owing to settlement between the parties.
