1. Matter was listed today pursuant to Orders passed by the Forum on 13.01.2026 and 27.01.2025, wherein Respondent had been directed to revise and issue to the Complainant a revised Demand Notice due to the fact of absence of any disputed amount in the said Demand Notice. Accordingly, Interim relief against disconnection of was granted to the Complainant till next date;
2. In this regard, compliance had been sought from Respondent;
3. Today Respondent places on record revised Demand Notice dated 31.12.2025, containing therein disputed amount of Rs 18,92,163/- along with the Reply in the matter;

In terms of statement made by the Ld Counsel for Complainant on 27.01.2025 wherein it had consented to deposit of statutory $\frac{1}{3}^{\text{rd}}$ of the disputed amount in accordance with regulation 25 of the HPERC (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, the Complainant is now directed to deposit the

said 1/3rd amounting to Rs 6,30,721/- within ten (10) days from this Order i.e on or before 07.02.2026;

5. On deposit of the said 1/3rd amounting to Rs 6,30,721/- on or before the said date of 07.02.2026, no coercive action shall be taken by the Respondent against the Complainant till further Orders;
6. On non-deposit of the aforementioned monies amounting to Rs 6,30,721/- by 07.02.2026, the Respondent shall be at liberty to take action as per applicable extant law / regulations;
7. On aforesaid terms the Application is disposed;
8. Pursuant to Reply filed by the Respondent, Complainant is now directed to file the Rejoinder in the main complaint on or before 24.02.2026;
