The officials in whose cases change of station is involved shall be entitled to usual TTA and joining time as admissible under the Rules.

The above officials on promotion should join at the place of posting within 5 days from the date of issue of these orders falling which their promotion will be deemed as forfeited and next official in the panel will be offered the promotion /posting orders. The controlling officers shall ensure
