OFFICE ORDER

Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Limited Pensioners/family Pensioners.

In continuation to this office order endorsement No. HPSEBL (SECTT) R&E/6-156/2023-14280-14360 dated 18.05.23 the Himachal Pradesh State Electricity Board Ltd., is pleased to decide that Dearness Relief @ 4% which is due from 1.7.2022 to Govt./HPSEBL pensioners/family pensioners including AIS pensioners/family pensioners shall be paid enhancing the existing rate from 34% to 38% from 01.04.2024 to the HPSEBL Pensioners/Family pensioners.

2. The Additional Dearness Relief shall be paid with the pension/family pension for the month of **April, 2024 to June, 2024 payable in the month of July, 2024** and the **arrears accrued from 01.07.2022 to 31.03.2024** shall be paid in the manner as may be prescribed by the separate orders.

3. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.

5. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority, (PDA) including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.

6. The Chief Accounts Officer, F&A Wing HPSEBL Shimla and authorized Public Sector Banks are requested to arrange the payment of Dearness Relief to pensioners/family pensioners on the basis of these orders.
