Sub: - Conduct of Nation-wide Pension Adalats in the State on Friday 23rd August 2019.

Sir,

With reference to your office letter No. HPSEBL (Sectt.) 409-25(Misc.)/2019-20-36667 dated 30.08.2019; on the subject cited above it is pointed out that as per Govt. of HP letter No. FIN (Pen) A (3) - 47 / 2016 dated 24.07.2019 (attached with your above referred letter), pension adalats were to be organised on 23rd August, 2019 but the letter has been forwarded to this office on 30.08.2019 i.e. after the scheduled date has passed. Therefore, action could not be taken as per requirement.

However, it is informed that HPSEBL has conducted pension adalats in the months of September and October, 2018 in almost all the districts. These adalats were conducted by Director (F&A), Chief Accounts Officer and AO / AAO Pension. Good number of pensioners and their representatives took part in these adalats and efforts were made to resolve their grievances on the spot or afterwards.
