I have been directed to draw your kind attention towards the grievances of power sector stake holding employees and engineers against the Central Government move towards privatization of power sector through Electricity (Amendment) Bill-2020 and Standard Bidding Document. All central trade unions and peasants of organization of the country are vehemently opposing the conversion of public monopoly to private monopoly.

National Coordination Committee of Electricity Employees and Engineers (NCCOEEE) the broad based united platform of all National Federation of Electricity Employees and Engineers has given a call for one day Strike/ Work Boycott on 3rd February, 2021 on the following demands and to express solidarity to struggling organization of peasants whose one of the main demands is withdrawal of Electricity (Amendment) Bill 2020 and the Central Trade Unions all over country fighting against privatization of PSUs:

- Scrap Electricity (Amendment) Bill 2020 & Standard Bidding Document towards total privatization of distribution of electricity.
- Withdraw the process of privatization of Electricity from public sector to private company in states and UTs and cancel all existing private Licenses and franchises in power sector.
- Reintegrate all power utilities in states and UTs with function components of Generation, Transmission and Distribution like KSEB Ltd. & HPSB Ltd.
- Re-introduce Old Pension Scheme and scrap New Pension Scheme. Forced retirement is not acceptable in Power Sector.
- Regularize all contract and casual workers/ employees averting legal complicity like Telengana State. Fixed Terms Employment is not acceptable in power sector.
- Fill in all existing vacancies with policy of regular jobs to be discharged by regular employees only.
