"CORRIGENDUM"

Order No. 68 /2022

WHEREAS in compliance to the judgement dated 13.11.2021 passed by the Hon'ble. Supreme Court of India in Civil Appeals No. 6649-6650 of 2021 titled as Ramesh Kumar & Ors etc. Vs State of Himachal Pradesh & Ors etc., Civil Appeal No. 6652 of 2021 titled Himachal Pradesh State Electricity Board Limited Vs Arjun Singh & Ors and Civil Appeal No. 6651 of 2021 titled Himachal Pradesh State Electricity Board Limited Vs Vipin Kumar Kaushal & Ors read with the judgement dated 4.3.2020 passed by the Hon'ble High Court of HP at Shimla in CWPOA No. 11/2019 titled Arjun Singh and another Vs State of HP and Ors, CWPOA No.12/2019 titled Vipin Kumar and Ors Vs State of HP and Ors and CMP No. 7984/2019 in CWP No. 2524/2017 titled Arjun Singh and another Vs State of HP and Ors, the HPSEB Ltd. has since re-shuffled and repositioned the seniority of the direct recruitee as also the promotee Assistant Accounts Officers and has further considered and made the promotions on the basis of reshuffled seniority position to the post of AOs/ Sr. AOs/Dy.CAO/Dy.CA and CAO/ CA vide Office Order bearing No. 52 dated 26.3.2022 endorsed vide No. HPSEB(Sectt)/GE/102-08/2022-89174-299 dated 26.03.2022.
