Subject: Providing of reservation to the distinguished Sports-Persons in various services under the Government-Instructions thereto regarding.

Sir,

I am directed to say that the State Government has provided 3% reservation to the distinguished sportspersons in the services of the State Government Departments/Public Sector Undertakings/Boards/Corporation etc. in direct recruitment vide Department of Personnel's letter No.2-11/72-DP(A-II), dated the 28th May, 1999. In the abovementioned instructions, no procedure has been prescribed regarding filling-up of vacancies reserved for Distinguished Sportspersons in the event of non-availability of suitable candidates. Consequently, such reserved posts remain unfilled and un-utilized for a considerable period.

2. The cases are being referred to the Department of Personnel to accord approval for filling-up the vacancies reserved for distinguished sportspersons from amongst the persons other than distinguished sportspersons, which remained unfilled due to non-availability of suitable sportspersons. In some cases, especially technical posts reserved for distinguished sportspersons are lying vacant due to non-availability of suitable distinguished sportspersons. It is also felt necessary that the process of sponsoring eligible sportspersons or issuing Non Availability Certificate (NAC) to the requisitioning departments/head of the departments by the Youth Services & Sports Department also needs to be made time bound so that the recruitment process may be completed as early as possible.

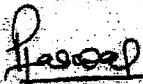
3. Therefore, after careful consideration the State Government has decided that the Administrative Department/Head of the Department shall send the requisition to the Sports Person Employment Cell established under the Youth Services & Sports Department. After sending the proposal, the department shall wait for a period of at least six weeks for the recommendation or non-availability certificate (NAC) from the YSS Department. If neither any recommendation nor NAC is received from the Youth Services & Sports Department within six weeks, it may be presumed as a deemed NAC. Thereafter, the requisitioning department may proceed further to complete the recruitment process from sportspersons of Category-IV as prescribed in para C(e) of instructions dated 28.05.1999.

4. It has also been decided that in the event of non-availability of suitable candidate(s), after having completed the prescribed recruitment process in accordance with Department of Personnel's instructions dated 28.05.1999 against the posts reserved for distinguished sportspersons in any recruitment year, the said vacancy(ies) thereafter will be filled up from amongst the candidate(s) of residuary category to which the point originally belongs, through the HP Public Service Commission or HP Staff Selection Commission or Departmental Recruitment Committee, as the case may be.

5. The instructions issued vide this department's letter No.2-11/72-DP(A-II), dated the 28th May, 1999 may be deemed to have been amended to this extent.

6. All the Departments/Public Sector Undertakings/ Corporation/Boards/Universities etc. are requested to bring the above instructions to the notice of all concerned for strict compliance.
