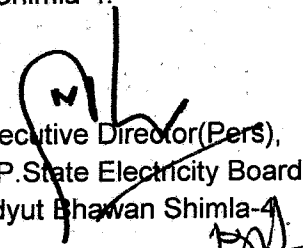

OFFICE MEMORANDUM

The Governor, Himachal Pradesh. is pleased to order the revision of the entitlement for ex-gratia grant to the families of regular Government employees/contractual employees who die while in service in the following manner:-

I	Regular employees	Three times of the basic pay subject to minimum of Rs. 55,000/- and maximum of Rs. 1,50,000/-.
II	Contractual employees	Three times of the basic pay subject to minimum of Rs. 35,000/- and maximum of Rs. 1,00,000/-.

2. The other terms and conditions as already issued from time to time will remain unchanged.
3. These orders will also be applicable to the officers of All India Services borne on the respective cadres of the State Government.
4. These orders will be applicable from 01.09.2022 and the cases relating to the period prior to 01.09.2022 shall be regulated in accordance with the existing orders and the cases already decided under those existing orders will not be re-opened.
