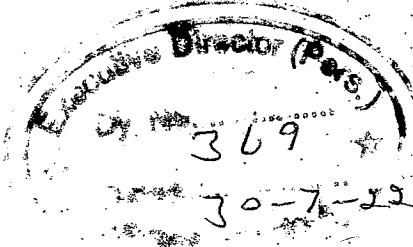
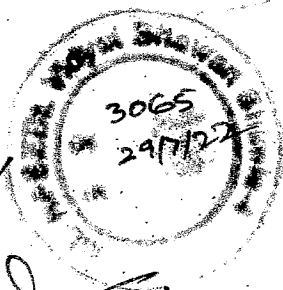
Subject:- General Transfers of Government employees – lifting of ban.

Madam/Sir,

I am directed to invite your attention this department's letter of even number dated 15th July, 2022 on the subject cited above vide which ban of transfer have been lifted w.e.f. 18-07-2022 to 27-07-2022 and to say that the State Election Commission has issued by-election programme for the conduct of elections to Panchayati Raj Institutions on 14-07-2022. With the issuance of the election programme, the Model Code of Conduct (MCC) has come into force in entire Shimla District, Development Blocks Gohar & Dharampur of District Mandi. Kunihar of District Solan, Bangana of District Una and Chamba of District Chamba (except in Urban Local Bodies falling in above Districts and Development Blocks) and 195 other Gram Panchayats of the State.

2. Accordingly, it is requested that transfer orders in respect of officers/officials posted in the areas where MCC is enforced may not be issued without the prior concurrence of the

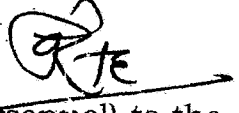
