2. Submit the document proof through post / by hand/ by e-mail regarding savings to be made by them under section 80c or others of the Income Tax Act for the purpose of Income Tax Deduction for each financial year by March of each year for the next financial year.
3. Submit the copy of PAN number, Aadhar number and also incorporate their mobile number of those pensioners / family pensioners who are currently drawing their pension from SBI Bank.
