Subject:- Business Reform Action Plan under Ease of Doing Business-Reduction of Documents required for obtaining the electricity connection.

Sir,

In continuation to this office letter No. HPSEBL/CE(Comm.)/S-4/Vol-IV/2017-18-9439-9813, dated 18-10-2019, No. HPSEBL/CE(Comm.)/S-4/Vol-III/2016-17-1461-1814, dated 05-05-2016, No. HPSEBL/CE (Comm.)/ S-4/Vol-III/2016-17-7067-7416, dated 30-08-2016, and in view of the notification of fifth amendment by HPERC on 14-01-2022, as circulated by this office letter NO. HPSEBL/CE(Comm.)/SERC-23/2021-22-12402-17, dated 05-03-2022, the documents required for release of new connection is detailed hereunder:-

A) Connection in the area where H.P Town and Country Planning Act, 1977 is applicable:-

1) Single Part Tariff Consumer (Domestic and other consumers with Contract Demand up to 20 KVA)

- i) Identity proof (i.e. Passport, Aadhar card, Voter card etc.) of the applicant.
- ii) Proof of applicant's ownership or occupancy over the premises for which new connection is being sought or in the absence of any proof of ownership or occupancy, any other address proof not given as part of identity proof under (i) above.
- iii) No NOC from any authority is required in this case.

2) For connections under Two Part Tariff (i.e. Contract Demand above 20 KVA), other than Domestic consumers.

- i) Proof of Identity of Applicant/User.
- ii) NOC/Floor-wise or entire building Completion Plan from TCP or MC or NP or other Urban Local bodies, as the case may be. The proof of ownership/occupancy (in case of owned/ leased premise) shall not be asked in case applicant is same in whose name the NOC/building completion plan is sanctioned. In other case, the same is required.
- iii) Authorization documents (in case of firm or company).

- iv) In case the applicant is not able to produce the documents as per Sr. No (ii) above, the connection shall be released under Temporary Metered Supply Connection along with undertaking/ declaration required as per clause No. 3.1.2.3 of Supply Code.

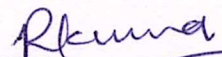
B) Connection in the area where H.P Town and Country Planning Act, 1977 is not applicable”:-

- i) Proof of Identity of Applicant/User.
ii) Proof of applicant's ownership or occupancy in case of owned / leased premises.
iii) Authorization document (in case of firm or Company).

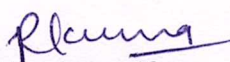

THAT the Applicant is a lawful owner/occupant of premises at(hereinafter referred to as "Premises").

THAT the Applicant has requested the Himachal Pradesh State Electricity Board Ltd. (HPSEB Ltd.) (hereinafter referred to as " The Licensee") to provide an electricity service connection at the above mentioned premises in the Applicant's name for the purpose mentioned in the Application and Agreement Form and the applicant is unable to produce No Objection Certificate(NOC) for electrical connection from [Name of respective concerned Authority].....

THAT I, the Applicant hereby agree and undertake/declare:

- 1) that the licensee may disconnect the electricity connection , in the event of a legally binding order issued by the Statutory Authority(ies) for disconnection of supply owing to any default /non -compliance of the statutory provisions;
- 2) that such connection released under temporary metered supply category, on the basis of this undertaking /deceleration shall be regularized, in the respective category , only after submission of either floor wise or entire building completion plan sanction letter issued by the concerned Statutory Authority(ies). This shall be without prejudice to any other rights of HPSEBL, including of getting its payment due as on the date of disconnection.

THAT in furnishing the present undertaking/ declaration, the Applicant has clearly understood that if any of the statements in this undertaking/ deceleration proves to be false or incorrect at any later stage, the licensee shall be within his lawful rights to disconnect supply to the premises without any prior notice and proceed to adjust electricity supply dues payable by the applicant against consumer security deposit and /or recover the same in accordance with Law.

THAT I, Applicant shall be held responsible, if the contents of the undertaking/deceleration are proved false at any stage and I/We indemnify HPSEBL of any consequences arising out of release of electrical connection to my premises.
