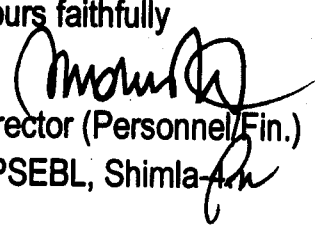
Subject: Regarding entry of visitors in the offices at Kumar House Complex.
Sir,

This is in reference to the instructions issued by this office in view of COVID-19 pandemic and the necessary precautions to be taken in this regard.

It has come to the notice of the authorities that large number of visitors is visiting Offices at Kumar House Complex for very small matters. And, taking notice of the available infrastructure of the Vidyut Bhawan Complex, it is not possible to maintain proper social distance required for the safety due to large number of increasing visitors and there is a need to make some restrictions in order to avoid unnecessary visit of visitors for unimportant matters to this office complex.

Therefore, in the interest of the public safety, it is ordered that no outside visitor (non official) except duly authorised by the Management shall be allowed to enter the Vidyut Bhawan Premises w.e.f. 15.6.2020. Further HPSEBL field Officials & employees are also requested to avoid unnecessary visits to the Vidyut Bhawan Complex and they must also seek prior permission in this regard. This is for necessary compliance of all concerned.
