Matter was listed today for filing Rejoinder/Arguments/Final Hearing in the matter.

In the last hearing, Counsel for Complainant, also present today, had prayed for filing Rejoinder and for Final disposal of the matter on next date.

However today Counsel for Complainant has filed an Application before the Forum for grant of Interim Relief in terms of restraining the Respondent from disconnection of the electricity supply of Complainant, having also stated there in that 1/3rd amount for Rs.5,74,000/- has been deposited on 08.05.2025.

Forum finds that copy of receipt for Rs. 5,74,000/- dated 08.05.2025 has been attached with Application.

Registry of Forum is directed to register the Application.

Forum observes that in this regard it has not passed any directions for deposit of 1/3rd amount, which the Complainant has done on its own.

Accordingly The Respondent is directed to confirm on next date the deposit of the said 1/3rd amount and whether such amount has been deposited against the disputed amount or against any other dues of Complainant.

Respondent is also directed to confirm on next date whether the Complainant is depositing the regular (current) bill amounts or not.

In view foregoing Application submitted on Affidavit by the Complainant, and ibid direction passed by Forum, Respondent is directed not to disconnect the electricity supply of the Complainant till the next date, when this Forum shall pass further Orders.

The Application is accordingly disposed.

Counsel for Complainant prays for filing of Rejoinder and final disposal on next date.

Prayer granted.

Main Complaint to come up for Rejoinder on or before 27.05.2025. Arguments/Final Hearing in the matter shall be held on 27.05.2025.

It may be noted by the parties that this final opportunity is granted to file the Rejoinder on or before 27.05.2025 and to argue the matter on 27.05.2025. In absence of any party on 27.05.2025 the complaint shall be proceeded ex-parte.
