Subject: - Instructions in compliance of orders passed in CWPOA No. 2531 of 2019-titled as Santosh Kumar & Ors. Vs. State of H.P. & Ors. by the Hon'ble High Court.

Madam/Sir,

I am directed to invite your attention to the Order passed on 29.09.2021 in case CWPOA No. 2531 of 2019-Santosh Kumar & Ors. Vs. State of H.P. & Ors. (the copy of order/judgment be downloaded from the official website of Hon'ble High Court from following link <https://hphighcourt.nic.in/#> for strict compliance).

2. One of the basis on which the Petitioners have filed the CWPOA No. 2531 of 2019 is that in the year, 2017, Himachal Road Transport Corporation advertised 1300 posts of Transport Multiple Purpose Assistants out of which some posts were reserved for Ex-servicemen General category. Despite of clear-cut instructions dated 09.06.2014 on the issue in hand, the HRTC permitted some Wards of Ex-servicemen (petitioners) to participate in the selection process against the vacancy reserved for Ex-servicemen and they were kept in select list of 1235 after document verification. Since, name of petitioners did not figure in the final selection list, they approached to the Hon'ble Courts by filing the aforementioned Civil Writ Petition.

3. After careful perusal of the advertisement issued by the Himachal Road Transport Corporation dated 03.08.2017 and corrigendum issued subsequently, the Hon'ble High Court has observed that in different categories posts were advertised for the category of Ex-servicemen and there is no mention in the advertisement that the wards of Ex-servicemen could apply against the post in question. Therefore, the Hon'ble High Court found no merit in the present petitions and accordingly the same stand dismissed.

4. The State Government vide Department of Personnel letter No. PER(AP)-C-B(12)-1/2014 dated 09.06.2014, has already defined a detailed procedure to fill up the vacancies reserved for Ex-servicemen. The above said instructions are reiterated and it is requested that while filling up the vacancies reserved for Ex-servicemen, these instructions be adhered strictly in letter and spirit (The instructions can be downloaded from the official website www.himachal.nic.in/personnel) and may be brought to the notice of all concerned for strict compliance.

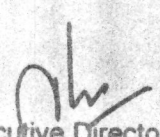

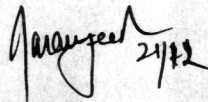
