"ORDER"

WHEREAS, Er. Manish Kumar Arya has been working as Senior Executive Engineer (Electrical) in Electrical Division, HPSEB Ltd., Kaza and, upon completion of his normal tenure, filed a writ petition bearing CWP No. 18233 of 2025 titled *Manish Kumar Arya vs. HPSEB Ltd. & Ors.* before the Hon'ble High Court of Himachal Pradesh at Shimla, seeking transfer to a station of his choice, namely Solan, Parwanoo, Nahan, Paonta Sahib, Baddi and Nalagarh.

AND WHEREAS, the Hon'ble High Court vide order dated 22.11.2025 directed the respondent-Board to consider and decide the petitioner's representation after affording him an opportunity of being heard, pursuant to which a detailed speaking order dated 09.12.2025 was passed adjusting Er. Manish Kumar Arya in Electrical Division, HPSEB Ltd., Nahan, vice Er. Mukesh Kumar, Senior Executive Engineer, who was transferred to Electrical Division, HPSEB Ltd., Kaza. Er. Manish Kumar Arya joined at Nahan on 11.12.2025.

AND WHEREAS, Er. Mukesh Kumar, Senior Executive Engineer, being aggrieved by his transfer to Electrical Division, HPSEB Ltd., Kaza, filed CWP No. 19728 of 2025 on the ground that he had attained the age of more than 55 years and, as per the transfer policy, could not be transferred to a tribal area. The Hon'ble High Court vide order dated 12.12.2025 stayed the transfer order and directed the competent authority to decide his representation. Consequently, vide order dated 20.12.2025, Er. Mukesh Kumar was retained in Electrical Division, HPSEB Ltd., Nahan and Er. Manish Kumar Arya was adjusted in Electrical System Division, HPSEB Ltd., Nalagarh.

AND WHEREAS, Er. Robin Kumar, Senior Executive Engineer, aggrieved by his displacement from Electrical System Division, HPSEB Ltd., Nalagarh, assailed the order dated 20.12.2025 by filing CWP No. 20572 of 2025, wherein he submitted that his minor daughter is suffering from Thalassemia and is undergoing treatment at PGI Chandigarh. The Hon'ble High Court vide order dated 24.12.2025 stayed the impugned order qua him and permitted him to submit a representation, which is under consideration by the competent authority.

AND WHEREAS, Er. Manish Kumar Arya also challenged his posting at Nalagarh by filing CWP No. 20535 of 2025. The Hon'ble High Court of Himachal Pradesh, vide order dated 06.01.2026, was pleased to quash and set aside the impugned transfer order dated 20.12.2025 and directed that Er. Manish Kumar Arya be transferred to Sub-SLDC, Hamirpur, as mentioned in the communication dated 05.01.2026.

AND WHEREAS, Electrical Division, HPSEB Ltd., Hamirpur is the home division of Er. Manish Kumar Arya and as per Clause-3 of the transfer policy, posting in the home

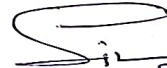
division is not permissible. However, a post of Senior Executive Engineer (Electrical) is lying vacant in the office of Sub-SLDC, HPSEB Ltd., Hamirpur, which is a non-operational office having no public dealing.

NOW, THEREFORE, in compliance with the directions dated 06.01.2026 passed by the Hon`ble High Court of Himachal Pradesh in CWP No. 20535 of 2025, and after due consideration of all facts and circumstances of the case, **Er. Manish Kumar Arya, Senior Executive Engineer (Electrical), is hereby ordered to be adjusted in the office of Sub-SLDC, HPSEB Ltd., Hamirpur against the available vacancy.**

Further, the adjustment orders issued vide order dated 20.12.2025 in respect of **Er. Robin Kumar, Senior Executive Engineer (Electrical), are hereby cancelled**, and **Er. Mukesh Kumar, Senior Executive Engineer**, shall continue to remain posted in **Electrical Division, HPSEB Ltd., Nahan.**

This order is issued in compliance with the judicial directions and in the interest of administrative exigencies.
